General

Except for any liability not excluded by law, Entrants release and indemnify the Promoter and the Participating Store from and against all actions, claims and liabilities, that the Entrant now has or in the future may have against the Promoter and/or the Participating Store, for any loss, damage or injury (including any special or consequential loss) suffered as a direct or indirect result of the Entrant's participation in the JAX Tyres & Auto Promotion.

Except as these Terms and Conditions specifically state, a Participating Store does not include by implication any other condition, term or warranty in respect of the quality, merchantability, acceptability, fitness for purpose, condition or description of a service or product provided in the applicable Participating Store.

Nothing in these Terms and Conditions is to be interpreted as excluding, restricting or modifying, or having the effect of excluding, restricting or modifying, the application of any State or Federal legislation applicable to the supply of goods or services that cannot be excluded, restricted or modified including but not limited to the Consumer Guarantees under the Australian Consumer Law.

To the maximum extent permitted at law, the Promoter and each Participating Store (and their respective agents, employees and officers) exclude all liability for any actions, claims, costs, demands, expenses, liabilities or loss (including any consequential or indirect loss) of any kind whatsoever arising from or related to the JAX Tyres & Auto Promotion.
